## Overview of last year's (2017-2018) process and goals

- D. Gelperin gave an overview of policy governance and monitoring. We have met with some of the operating committees to learn what is needed to achieve the goal of strong committees. We read the "Folly" book to learn about congregational growth and how to deal with it. A congregation needs a shared vision to flourish. What animates us? We did not find an easy answer. We may need to continue looking at it. The board has started to have a second monthly meeting to allow more time for discussion.
- B. Marie-Daly described the Safety Circle discussions which were held with members of the congregation. Some members did not feel seen, heard, or respected. The original

intent was to meet with members of committees, not the committee chairs. We worked with PCRR on this. The Board has handed the continuing work in this area to PRCC.

## Overview of this year's (2018-2019) process and goals

P. Myers continued the discussion of a congregational meeting. Our thinking tends to be insular. Our vision will be bigger than we are. We are starting with CONECT and other activities. Barber's book will be discussed in relation to the need for a bigger vision. We need to continue working with other committees. Some committees are now using guided check-ins. Latham talks about an "energy audit". What are we doing? That will indicate the mission. We are going to do an energy audit this year. We need to improve communication with the congregation. Board chats have not been enough. We need help with social communication. We will look for people or ideas to help with this topic.

#### Minister's Report June 14, 2018 Rev. Megan Lloyd Joiner

#### Stewardship

The Stewardship Campaign resulted ~ \$430,000 in pledges. Calls are still being made the few outstanding households. We have budgeted \$445,000 in pledges.

<u>Personnel</u>
We had to rescind an offer that we made to an individual to serve as the Hospitality Coordinator. We will resume the search and start the search for the Membership Coordinator (starting date: August, 2018).

Affiliated Minister
The Rev. Kathleen Green, Executive Director of the Yale Humanist Community (YHC), was introduced to the congregation on June 10. She will preach on August 12. We will also arrange Q&A and hope to vote on affiliation with her in the fall of 2018.

<u>Summer Services</u>
Our summer services are planned and will include a mix of lay-led worship and guest ministers. I will preach the last two Sundays in August.
